Upon Termination of service (by you or New Windsor Cable TV) you will pay in full for your use of services up to the day of disconnection; and will return all equipment to us in working order to our business office or make arrangements for our agents during normal business hours to retrieve said equipment within ten (10) days after termination date. Otherwise, you will be charged the amount set forth on current equipment pricing lists.

New Windsor Cable TV, Inc will provide one (1) external High Speed Internet modem at the time of the initial application. The only warranty covering the external High Speed Internet modem provided by New Windsor Cable TV, Inc is the manufacturer's warranty of thirty (30) days. Beyond the 30 day manufacturer's warranty, customer is responsible for repair or replacement of the modem.

New Windsor Cable TV, Inc provides the customer the option of a wireless modem/router. The wireless modem/router is maintained by New Windsor Cable TV, Inc and a \$2.50 monthly wiring maintenance fee is billed. An additional set up fee is charged at the time of installation.

New Windsor Cable TV, Inc High Speed Internet requires an Ethernet card (contact customer service at 309-667-2150 for further information). The customer is responsible for the purchase and installation of the Ethernet card.

New Windsor Cable TV, Inc High Speed Internet is an ALWAYS on connection. Obtaining and maintaining an adequate firewall system to prevent hackers is the CUSTOMER'S responsibility.

The range of speeds listed on the application will be achieved between the customer and New Windsor Cable TV, Inc High Speed Internet equipment. New Windsor Cable TV, Inc cannot guarantee speeds after this due to traffic of congested sites.

New Windsor Cable TV, Inc High Speed Internet DOES NOT include dial up access.

New Windsor Cable TV, Inc High Speed Internet includes one (1) E-mail address. Additional E-mail addresses can be obtained for \$3.00/address/month.

NEW WINDSOR CABLE TV, INC. HIGH SPEED INTERNET TERMS AND CONDITIONS

- 1) By signing this registration form and agreement, you (customer) must be at least 18 years of age and agree to the following terms and conditions of the service described below.
- 2) These services are provided by New Windsor Cable TV, Inc., PO Box 488, New Windsor, IL 61465 in conjunction with WINS, PO Box 359, Colchester IL 62326. This agreement shall be governed by and construed in accordance with the laws of the state of Illinois applicable to contracts to be performed entirely within the State.
- 3) The external High Speed Internet modem will be provided by New Windsor Cable TV, Inc and, in consideration for New Windsor Cable TV, Inc providing the High Speed Internet modem. Customer agrees to pay the application fee and the monthly service fee for a minimum of six (6) months. If the service is terminated within the first six (6) months of the signed agreement, the Customer must continue to pay the monthly service fee for the remainder of the initial 6-month term. Both New Windsor Cable TV, Inc and Customer may terminate this Agreement at any time, after the initial 6-month term, by giving written notice to the other. Such notice is effective when given and Customer is obligated to pay for service through the termination date. The only warranty covering the external High Speed Internet modem provided by New Windsor Cable TV, Inc is the manufacturer's warranty of thirty (30) days. Beyond the 30-day manufacturer's warranty, Customer shall be responsible for repair or replacement of the modem with like equipment.
- 4) In order to properly maintain the New Windsor Cable TV, Inc High Speed Internet network, New Windsor Cable TV, Inc reserves the right to change Customer's IP, gateway and subnet addresses.
- 5) All High Speed Internet charges will be billed by New Windsor Cable TV, Inc at the first of each month, included in your New Windsor Telephone Statement, payable by the 21st of that same month. Failure to pay by the specified due date may result in your service being discontinued. A reconnect fee will be required to reestablish service. A deposit may also be required.
- 6) If your New Windsor Cable TV, Inc High Speed Internet account is discontinued for any reason, New Windsor Cable TV, Inc assumes no responsibility for recovery of your data from WINS.
- 7) New Windsor Cable TV, Inc makes no express or implied warranty of any kind. There is no express or implied warranty of merchantability or fitness for a particular purpose for the services to be provided by New Windsor Cable TV, Inc.
